Minutes of a regular meeting of the Vermilion Parish Police Jury held on July 02, 2018, with President Kevin Sagrera presiding.

The meeting was called to order by President Mr. Kevin Sagrera, who asked Mr. Wayne Touchet to lead the group in the Pledge of Allegiance. Following the pledge, the President asked Mr. Ronald Darby for a moment of prayer or reflection. The President then reminded all present to turn all cell phones, pagers, etc. off or set to silent mode for the duration of the Police Jury Meeting.

President Sagrera recognized a period for public comment on any agenda item to be considered.

No business to be presented at this time.

President Sagrera recognized Time on the Agenda, Donna Libersat – Brice Romero Memorial Fund Swimming Lessons.

Ms. Donna Libersat stated this is the ninth year doing the fundraiser. The first year they raised money for the funeral expenses for Brice who drown two weeks after graduating high school. This year it is costing over \$1,000.00 to provide swimming lessons for under privileged children. The children show up to the lessons and if the parent chooses they can donate five dollars. The money donated helps buy the snacks we give out on the last day of lessons. This year we have children from Kaplan, Erath and Abbeville. Lessons will start back up Monday, July 9, 2018 at 105 Hickman in Delcambre. If any of you could donate it would be appreciated.

President Sagrera recognized Reading or Approval of the minutes of the previous meeting-Regular Meeting of June 18, 2018.

Upon motion by Mr. Leon Broussard, duly seconded by Mr. Paul Bourgeois, and unanimously carried, the Police Jury approve to dispense of the reading of Regular Meeting of June 18, 2018.

President Sagrera recognized to consider action to amend the agenda to discuss and consider actions on any new items presented by Engineering and Architectural reports.

Upon motion by Mr. Ronald Darby, duly seconded by Mr. Brent Landry, and unanimously carried, the Police Jury approve to amend the agenda to discuss and consider actions on any new items presented by Engineering and Architectural reports.

Mr. Todd Vincent, Sellers & Associates, Inc., presented two permit applications in Election District 13. Peak Operating Company is requesting both a drilling and pipeline permit to install a well off of Schooner Bayou Canal. We recommend Permit No. 1797-D and 1796-P be approved.

Upon motion by Mr. Leon Broussard, duly seconded by Mr. Pervis Gaspard, and unanimously carried, the Police Jury approve Permit No. 19797-D and Permit No. 1796-P to install a well off of Schooner Bayou Canal.

Mr. Todd Vincent presented the three changes of the renewal contract. 1) The effective date will be February 1, 2019. The term of the contract will be for two years beginning February 1st with an option to renew the contract for an additional three years. 2) The fines have been updated to \$50.00 per truck. Failure to collect verified missed collections within twenty-four hours of notification to the contractor, \$50 each day. Complaints on a route after notifications of spilling, crossing planted areas or similar violations shall be corrected within twenty-four hours, \$50.00 each if not corrected. Failure to place new containers and replace damaged containers will also be \$50.00 each day. 3) Prior to the extension of the contract the contractor shall pay the Vermilion Parish Police Jury one half the sum of \$3,700.00 and one half of \$11,900.00 for a total of \$7,800.00. Payment due upon signing the contract. Contractor shall refund to Vermilion Parish Police Jury prior to the extension of the current contract the sum of \$15,000.00 for the lack of public promotion. \$6,000.00 to be paid upon signing the contract, 2019 spend \$4,500.00 plus \$3,000.00 for public promotion, 2020 the same as 2019. This is all changes to the contract.

Mr. Gene Sellers, JR, The Sellers Group, presented an update on the County Agent Building. Contractor made good progress but is still behind. We are thinking he is thirty to forty days late. There is a \$500.00 per day charge for everyday he doesn't complete the work within the time frame. The contractor has offered to do additional work that may be needed at that project. This way he would get a time extension and do additional work. For example, the City of Abbeville has a requirement that you can't slope the grade straight down, you have to build a retaining wall. The contractor is proposing to build the wall at no cost to the Jury. This is about \$13,500.00 worth of work. He would do that value of work in exchange for the twenty-seven days and not charge him the damages. In addition he would need time to perform the work since it is additional work. It would expand the scope of his services. He is proposing it to be eighteen days, which I think it is a little more than what it would take him, maybe fourteen days. You would sign a change order for zero dollars and add the scope of that responsibility to his contract to build the retaining wall and you would give him the additional days of twenty-seven for the value of the work and fourteen

days for the additional work. Currently the completion date is August 18th. With his request of forty-five days, the completion date would be October 2nd.

Upon motion by Mr. Wayne Touchet, duly seconded by Mr. Pervis Gaspard, and unanimously carried, the Police Jury approves to grant the extension of twenty-seven days in exchange for Mourain Construction building the wall for the landscaping plus fourteen days for the additional work.

President Sagrera recognized Report of Standing Committees, Courthouse/Building Committee.

President Sagrera stated we wanted to know where we stand with the training and wanted clarification on where we are at and what is the next step.

Ms. Becky Broussard, VPOEP Director, stated they had a meeting with Keith Thursday morning. Homer is going to continue to do the volunteers and workers for the point to point. He requested that I do the transportation. She has a Memorandum of Understanding with the School Board. Would like a motion for Paul to review it and once it is correct the President sign.

Upon motion by Mr. Ronald Darby, duly seconded by Mr. Brent Landry, and unanimously carried, the Police Jury authorize Legal Counsel to review the Memorandum of Understanding between the Police Jury and the School Board and authorize the President to sign.

Mr. Homer Stelly, Assistant VPOEP Director, stated he is giving his Letter of Resignation effective December 31, 2018.

Upon motion by Mr. Errol Domingues, duly seconded by Mr. Ronald Menard, and unanimously carried, the Police Jury authorized Homer to set up a plan for an evacuation and bring back to the Jury.

President Sagrera recognized New Business, Legal Counsel, Mr. Moresi.

Mr. Paul Moresi, III, Legal Counsel, presented some requirements of the Open Meeting Law, such as, posting at the beginning of the year all of the meetings and post agenda and notice of meeting twenty-four hours before each meeting. If you recall you approved the hiring of Mr. John Young for the Opioid Litigation. We wrote to the Attorney General asking for permission and requested a more specific resolution for the reason why you need special counsel. I got with Mr. Young and drafted a more specific resolution that sets forth the reasons why there is a need to pursue these claims that Mr. Young and the other attorneys have specialized knowledge and there is a real need to have outside counsel to represent VPPJ. I would suggest for you to first amend the agenda and then adopt the resolution.

Upon motion by Mr. Ronald Menard, duly seconded by Mr. Leon Broussard, and unanimously carried, the Police Jury approve to amend the agenda to discuss the resolution concerning the Opioid Litigation.

Upon motion by Mr. Ronald Darby, duly seconded by Mr. Wayne Touchet, and unanimously carried, the Police Jury approve to adopt the resolution to send to the Attorney General to be approved.

Mr. Paul Moresi, III presented the lawsuit over the boundary with Iberia Parish. The lawsuit has been filed and assigned to a judge in Lafayette. Received a letter from the office of Jay Darden stating they had received the letter concerning the Vermilion and Iberia Railroad District. They are going to send it to the oversite committee. Early next year we can get together and see if we can change the law to make the requirements more tangible to be able to appoint people.
