Minutes of a regular meeting of the Vermilion Parish Police Jury held on May 16, 2016, with President Ronald Darby presiding.

President Darby recognized at this time a period from public comment on any agenda item to be considered from the audience.

No comments were presented or discussed at this time.

President Darby recognized Ms. Donna Libersat, with the Brice Romero Memorial to present her business to the Jury.

Mr. Donna Libersat stated to the Jury that last year we had approximately 30 people we taught swimming lessons, about 25 children and 5 or 6 adults. As a Jury, I know you cannot donate anything but as individuals you really helped us out last year. In teaching 30 students last year it really depleted the funds. We are not wanting to turn anyone down but we can only do so much with the amount of funds we have. So anything the Jury as individuals can do to help would be appreciated. Mr. Gene Sellers, Sr., with Sellers & Associates, Inc., stated that the residential developer's subdivision called D. W. Voorhies Estate, we reviewed their final plat for the subdivision and we have a few comments for them to do but subject to these comments we recommend final approval in Election District No. 3. It is on an existing road that they are making 5 lots.

Upon motion by, Mr. Nathan Granger, duly seconded by Mr. Wayne Touchet, and unanimously carried, the Police Jury granted Final Plat approval to the Subdivision development identified as D. W. Voorhies Estate, contingent upon engineer's comments, in Election District No. 3.

Mr. Kim Touchet stated that the contractor 45 day lien period is up on Phase IV which is Cypress Point Road & Riceville Road Bridges. He has submitted the clear lien certificate, and we recommend final payment of \$14,556.00 for L & R Construction.

President Darby considered action to amend the agenda to discuss and consider actions on any new items presented by the Parish Administrator.

Upon motion by Mr. Ronald Menard, and duly seconded by Mr. Cloris Boudreaux, and unanimously carried, the Police Jury amend the agenda to discuss and consider actions on any new items presented by the Parish Administrator.

ORDINANCE

2016-O-12

WHEREAS, it has been brought to the Police Jury’s attention that a considerable amount of speeding exists, which is causing very hazardous conditions on Gallet Road for its entire length, in Election District No. 3.

SECTION I: NOW THEREFORE, BE IT HEREBY ORDAINED, that the Vermilion Parish Police Jury does hereby impose a 35 mph speed limit on Gallet Road, for its entire length, in Election District No.3.

SECTION II: BE IT HEREBY FURTHER ORDAINED, that the appropriate speed limit signs be installed in said area.

SECTION III: BE IT HEREBY FURTHER ORDAINED, that for a first offense, a maximum penalty of a \$100.00 fine and/or a 10 day jail sentence be imposed at the discretion of the court for the first offense.

BE IT HEREBY FURTHER ORDAINED, that for a second offense, a maximum penalty of a \$250.00 fine and/or a 10 day jail sentence be imposed at the discretion of the court.

BE IT HEREBY FURTHER ORDAINED, that for a third offense, a maximum penalty of a \$500.00 fine and/or a 10 day jail sentence be imposed at the discretion of the court.

SECTION IV: BE IT HEREBY FURTHER ORDAINED, that the Vermilion Parish Sheriff's Department be and is hereby requested and/or directed to enforce the speed limit by the use of radar and/or regular patrolling.

Upon motion by Mr. Jason Picard, duly seconded by Mr. Nathan Granger, and unanimously carried, the Police Jury approved to hire Ms. Randee N. Vincent as a Part Time employee at the Area IV Barn.

Upon motion by Mr. Mark Poche', duly seconded by Mr. Wayne Touchet, and unanimously carried, the Police Jury approved payment of Invoice Dated 05/05/16 to LaSalle Correctional Center, in the amount of \$18,731.52, relative to the housing of inmates for the Month of April, 2016.

Upon motion by Mr. Errol Domingues, duly seconded by Mr. Cloris Boudreaux, and unanimously carried, the Police Jury approved approve payment of Invoice No. 4353, to The Sellers Group, in the amount of \$18,260.60 relative to Professional Services thru Schematic Design, for the "Multi-Purpose Building at the County Agent Complex.". Cost to be paid from 78' Sales Tax.

Upon motion by Mr. Paul Bourgeois, duly seconded by Mr. Errol Domingues, and unanimously carried, the Police Jury approved payment of Invoice No. 16-G020-01, to Site Engineering, LLC, in the amount of \$3,400.00 relative Geotechnical Engineering Service Report – lump sum, relative to the "Multi-Purpose Building at the County Agent Complex.". Cost to be paid from 78' Sales Tax.

Upon motion by Mr. Leon Broussard, duly seconded by Mr. Sandrus Stelly, and unanimously carried, the Police Jury approved payment of Invoice No. 125005, to Thermal Insulation Contractors. Inc., in the amount of \$18,713.00 relative to Replace gutters, downspouts and associated rake trim at the Cecil McCoy Exhibition Building at the County Agent Complex. Cost to be paid from 78' Sales Tax.

Upon motion by Mr. Ronald Menard, duly seconded by Ms. Cloris Boudreaux, and unanimously carried, the Police Jury approved payment of the attached bills that were submitted.

President Darby recognized Mr. Paul Moresi, III, Legal Counsel, to present his business to the Police Jury at this time.

Mr. Moresi, informed the Jury that he reviewed the contract between T&M Aviation and I think the proper way to handle this basically is to do an assignment of that contract to the new contractor then I can do a simple one page letter agreement that will be a form of an assignment that I am wanting them to sign off on understanding that they are bound by the same terms and conditions of the contract that you have with T&M Aviation. Calling it an Assignment means they will be stepping into the shoes of a new contractor.

Mr. Moresi, informed the Jury he looked at the Council on Aging's contract and stated, I do not see a legal way for the Jury to approve the Financial Activity Report that is uncertain at the time to approve. If it was a type of contract that you knew every month what it was going to be "x" and you wanted to approve that, you could probably make that work but otherwise I do not know how to do it any other way.

Mr. Moresi, stated he has been trying to get in touch with Iberia Parish Government relative to the Iberia / Vermilion Railroad Development District, I did get one phone call back from the Attorney with Iberia Parish Government and he asked me to see whether the Jury thought it was worth our wild and I stated, I guess that's why the Jury is asking you the same question. I have a call in today already about this and I will stay in touch.

Mr. Moresi, is needing to talk to the Jury about 3 adjudicated properties, one of the properties you have already tried to sell which is at 826 N. East St. Abbeville, LA. There is a demolition lien for \$2,200.00 and you tried to sell it for \$1,500.00 and you got no bids. The other property is 803 S. St. Valarie Abbeville, LA, this one has \$5,000.00 worth of demolition and grass cutting liens on it. So with that being said, the City of Abbeville is interested in doing the same type of intergovernmental agreement with these two adjudicated.

Upon motion by Mr. Paul Bourgeois, duly seconded by Ms. Wayne Touchet, and unanimously carried, the Police Jury amend the Agenda to consider adopting a resolution to enter into an Intergovernmental Agreement with the City of Abbeville for

the following two adjudicated properties, 826 N. East St. Abbeville, LA & 803 S. St. Valarie Abbeville, LA.

Upon motion by Mr. Paul Bourgeois, duly seconded by Ms. Wayne Touchet, and unanimously carried, the Police Jury adopted a resolution to enter into an intergovernmental agreement with the City of Abbeville on two (2) adjudicated properties and in return of transfer of ownership of the properties, the City of Abbeville will give up the claims against the parish on the liens and authorized Mr. Paul Moresi, III, Legal Counsel to prepare necessary documents.

2. 803 S. St. Valarie Abbeville, LA)

Mr. Moresi, also stated that he received a call from Mr. Stanley Stufflebeam. apparently he was living in Lafayette Parish, in 1992 he bought a piece of property in Vermilion Parish. He thought he was going to be homestead exempt but, because of his address on his deed it showed he was living in Lafayette Parish and not on the property he bought in Vermilion Parish. The tax notices were being sent to his address in Lafayette Parish. So, in 1993 it was adjudicated to the parish, and Mr. Stufflebeam built a home on this property. I sent Mr. Stufflebeam to talk to Mr. Gabe Marceaux, Tax Assessor and Mr. Marceaux asked me what's the Police Jury's position? I did some research and until you actually take action Mr. Stufflebeam still can redeem this property. If Mr. Stufflebeam would redeem the property it would restore his title. Mr. Stufflebeam would have to get this straight with the Assessor's Office, but I do not know if the Assessor can go back 23 years and give him the homestead retroactive. So, first Mr. Stufflebeam and the Assessor needs to straighten this situation out and then the Jury can do a redemption and might have to do something called a Quick Claim Deed where it says we do not claim any ownership in this property.


