Police Jury Room July 5, 2016 Abbeville, Louisiana

Minutes of a regular meeting of the Vermilion Parish Police Jury held on July 05, 2016, with President Ronald Darby presiding.

The meeting was called to order by President, Ronald Darby who asked Mr. Wayne Touchet to lead the group in the Pledge of Allegiance. Following the pledge, Mr. Nathan Granger took a moment to give prayer and reflection, President Ronald Darby asked for all phones, pagers, etc. off or set to silent mode for the duration of the Police Jury meeting.

President Darby recognized at this time a period from public comment on any agenda item to be considered from the audience.

No comments were presented or discussed at this time.

Mr. Paul Moresi, III, Legal Counsel stated that Mr. Patrick Donohue, Angelle & Donohue Oil & Gas Properties, Inc. requested to address the Jury tonight regarding the proposed nomination of Parish Properties for Oil, Gas & Mineral usage.

Upon motion by Mr. Errol Domingues, duly seconded by Ms. Paul Bourgeois, and unanimously carried, the Police Jury amend the agenda to allow Mr. Patrick Donohue, with Angelle & Donohue Oil & Gas Properties, Inc., to speak regarding the proposed nomination of Parish Properties for Oil, Gas & Mineral usage and also amended the agenda to allow Mr. Althea Franklin, Director of the St. Mary Community Action Agency & Head Start Program to speak relative to the DOTD Section 5311 Program to use St. Mary Community Action Agency.

Mr. Patrick Donohue, with Angelle & Donohue Oil & Gas Properties, Inc., stated he is an Abbeville resident, back on June 20, 2016 he requested some Vermilion Parish Police Jury acreage be nominated for lease. He visited Mr. Moresi on this and spoke about a minimum bid of \$200.00 per acre, 20% royalty for a three (3) year lease. Being the same minimum bid requirement that was worked out on a lease that was taken from the Vermilion Parish Police Jury on Motty Country Manner, which was Motty Loop and a lot in Motty Country Manner. At that lease sale they bided \$200.00 and 22.5% royalty, even though the minimum royalty was 20%. Mr. Donohue heard from Mr. Moresi that at the meeting of June 20, 2016 the Police Jury voted to raise the minimum to 25% on a seal bid basis, with the \$200.00 per acre bonus in rental with a three (3) year term. Mr. Donohue is respectfully requesting that the Jury decided to amend the minimum to 22.5% royalty rather than the 25% royalty.

Upon motion by Mr. Wayne Touchet, duly seconded by Ms. Dane Hebert, and Mr. Nathan Granger abstaining, the Police Jury authorized Mr. Paul Moresi, III, Legal Counsel to prepare the necessary documents to nominate the following land (total of 19.308 acres), State Agency Hydrocarbon Lease to Vermilion Parish Police Jury, Vermilion Parish, Louisiana Leases by State Agencies to 22.5% royalty.

Ms. Althea Franklin, Director of St. Mary Community Action Agency & Head Start Program stated they would like to make a presentation about the transportation services in Vermilion Parish. They are here to offer Section 5311 Transportation Services to Vermilion Parish just like in St. Mary Parish. They are the providers of the Head Start Program here in Vermilion Parish as well. They are located in eight (8) other parishes along with St. Mary and Vermilion Parish. They believe that an effective an efficient transportation service can be provided.

Ms. Franklin stated that she believes that the Vermilion Transportation Service was going to Lafayette and Iberia Parish, they are proposing to provide services within the Parish area, have designated days for the drivers to be in designated areas. They will also honor the contracts with the Abbeville Hospital also any other service they need to, to make sure that clients get to the needed doctors, etc.

Mr. Jeff Beverly, Director of Housing Development for the St. Mary Community Action Agency stated that he spoke with Troy Hair, CFO of Abbeville General Hospital whom did a little history and went back over the past few months. They were averaging about nine (9) patients per day. With the reimbursement of \$20.00/ round trip. Which he stated that would be defiantly something they could work with.

Ms. Franklin also stated that a big problem with the transportation program is that they did not have the match in place. Those of you whom had the opportunity to speak with the representatives from the State of Elderly Affairs and the Department of Transportation. The transportation program is a match program. The Vermilion Parish Police Jury does contribute some money but, the other monies have to be in matched

with services. Medical Transportation Services can charge Medicaid for some of their services. The Federal Government requires that the Police Jury put something into the program because it benefits the residents of Vermilion Parish.

Mr. Beverly also stated that their budget is not as high as the budget that is in place. They could start off with a minimum amount of services and increase as they see necessary to be able to operate effetely. They want to be sure there is no problem giving the services that they need with also staying in business.

Ms. Duhon stated that the Section 5311 Transportation Program is funneled through the Vermilion Parish Police Jury and the Jury has the right to choose who they want to run the transportation program. As of now there are six (6) buses, out of those there are two (2) Federal Transit Administration and four (4) that are titled under the Vermilion Parish Police Jury. Also, out of the four (4) titled to the Police Jury, two (2) are not in running conditions.

Mr. Beverly stated that the Federal Transit Administration funnels money down to the state and each government, DODT operates that for the government.

Ms. Duhon stated that in February of this year Council on Aging applied for their Section 5311 Transportation Application. They applied for \$310,376.00 and the state provides half. Which would be \$155,188.00.

Mr. Beverly stated when DODT was here one of the question to them was, if they could amend the agreement/application with DOTD for the budget that is in place now. DODT stated that they were willing to work with them on this. All the money that is contracted out does not need to all be spent. They are proposing this to start off with to see how everything is running before they start up any other services.

Ms. Duhon stated that she went visit with Ms. Clarise Landry at the Vermilion Council on Aging office, I found out that the transportation side owes approximately \$12,797.67 of outstanding invoices. Plus, Vermilion Council on Aging owes one pay period which includes six (6) employees on the transportation side. The Police Jury's agreement is with the Vermilion Council on Aging for the Section 5311 Transportation and that is the area that concerns me. Ms. Duhon stated that she received a call today from DODT and the check is going to be mailed in the amount of \$7,383.00 for the month of May for the transportation expenses. Ms. Landry worked very hard today to get the June report ready so we can have it in by July 11, 2016 if not the money will be lost.

Mr. Paul Moresi, III, Legal Counsel stated that what the Jury could do when the money comes in, they could make the check out to Vermilion Council on Aging and the vendor therefore they would have to provide a signature and forward it to the vendor. One thing that concerns me, is that the board has been disbanded. The money

that the Jury will get from the State for transportation is the Jury's responsibility to make sure that the money goes where it is designated to. The Vermilion Parish Police Jury has an IGA with the State of Louisiana stating that you will do what you are supposed to do with the money.

Upon motion by Mr. Wayne Touchet, duly seconded by Ms. Jason Picard, and unanimously carried, the Police Jury approved to designate St. Mary Community Action Agency as the Sub-recipient for the Section 5311 Transportation Program in Vermilion Parish, and authorize the President to sign the contract, also to inform the City of Abbeville that St. Mary Community Action Agency will be the new Sub-recipient for the Section 5311 Transportation in Vermilion Parish.

President Darby recognized Mr. Stephen Humphreys to discuss Ordinance 2008-O-37 Regulation Animal Control, Article IV. Control of Animals A. Dangerous Dogs to present their business at this time:

Mr. Stephen Humphreys stated he lives on Judge Doucet Road in Abbeville, this is the second time his dogs have been impounded for being dangerous. The dogs were on his property, one of them is an American Bulldog and a smaller Pitbull. The first time this happened was last summer they went on vacation and his cousin came and let the dogs out to use the restroom. The neighbor's dog was under his carport and he attacked him and he died. This time the same neighbor let their dog out and he was in my backyard and his dogs saw the dog in the backyard and attacked it. Mr. Humphreys stated that the Female got into the fight as well, they had just had a litter of puppies and he still has puppies in the house. Both times the neighbors have not had their dog on a leash or built a pen. Mr. Humphrey stated his dogs have an underground electric fence and have never left his property. The neighbor tried to state that his dogs ran across the electric fence, which is a twenty (20) foot wide strand of fence, ten (10) foot on each side of the wire, grabbed his dog and put it back on his property. He would have gotten shocked twice. The neighbors are the only one's who has seen it happen both times. The first time they beat his dog under his carport with a boat paddle to get him to let go. The first time was a small dog breed and the second time was a Great Dane. Mr. Humphrey states that the dogs have all of their shots and he built them a fence. Mr. Billy Noegel, Public Works Director let him know that the electric fence is good to keep his dogs in his yard but will not keep other dogs out. There are beware of dog signs in his yard, he was told to put up more.

Mr. Billy Noegel, Public Works Director stated that the Ordinance says that it is unlawful for the owner or keeper of a dangerous dog to have the animal on the property without securing the dog from public contact by confining the dog in manner approved by animal control officer that shall prevent the entry of the general public and to preclude any release or escape of the dangerous dog. Mr. Noegel stated that underwire fence was approved last July but all that does is keep his dogs on his property. The reason the dog was named dangerous was because the dog came on the property. The

problem is other dogs coming on his property not his dogs leaving. The neighbor called asking what kind of fence does he have to build and Mr. Noegel stated to them that either a chain link or a privacy. Mr. Humphrey asked if the Ordinance states that and Mr. Noegel looked back at it and it does not actually state that in there. Mr. Noegel decided to bring this to the Jury and have Mr. Paul Moresi, III, Legal Counsel to take a look at it, if his fence is sufficient.

Mr. Moresi stated you are supposed to confine your animals on your property. If the neighbor's dogs comes on his property then they should be written up also. Once the dog is deemed a dangerous dog, then it is supposed to be confined in a way. Mr. Moresi stated he would agree with Mr. Noegel that an electric fence will not do it because it will not keep other animals out. He thinks they need to defer that judgement to Animal Control whether or not this is sufficient to keep the dog in and to keep the public out.

Mr. Noegel stated that he feels that as long as the dog does not leave the property and the only way to fine the others for coming into his yard is to have video or to prove it.

The Jury stated to follow Billy Noegel's recommendation.

Upon motion by, Mr. Leon Broussard, duly seconded by Mr. Sandrus Stelly, and unanimously carried, the Police Jury approved dispensing of the reading of the minutes of the June 20, 2016, regular meeting, and was accepted as presented.

President Darby considered action to amend the agenda to discuss and consider actions on any new items presented by Engineering & Architectural reports.

Upon motion by Mr. Ronald Menard, duly seconded by Mr. Kevin Sagrera, and unanimously carried, the Police Jury approved to amend the agenda to discuss and consider action on any new items presented by the Engineering & Architectural reports.

President Darby recognized Mr. Gene Sellers, Sr., with Sellers & Associates, Inc., to present his business to the Jury.

Mr. Gene Sellers, Sr., with Sellers & Associates, Inc. stated he has a Contract Change Order No. 1 for the Erath High and Middle Schools Flood Protection HMGP, this is to adjust some quantities there are some items that we need to add and take off. It is a decrease of -\$6,017.00. Would like a motion to approve Contract Change Order No. 1 to reduce the contract by -\$6,017.00.

Upon motion by Mr. Leon Broussard, and duly seconded by Mr. Cloris Boudreaux, and unanimously carried, the Police Jury approved Change Order No. 1 to M. P. Dumesnil Construction Co., LLC., to adjust contract quantities to reflect field changes

once project begins construction at a decrease of -\$6,017.00, relative to the "Erath High and Middle School Flood Protection HMGP #1786-113-001".

Mr. Gene Sellers, Sr. stated he has Partial Payment No. 4 to M.P. Dumesnil Construction Co., LLC, for the work completed on the same project in the amount of \$270,452.54.

Upon motion by Mr. Mark Poche', and duly seconded by Mr. Pervis Gaspard, and unanimously carried, the Police Jury approved Partial Payment No. 4 to M. P. Dumesnil Construction Co., LLC., in the amount of \$270,452.54, relative to the "Erath High and Middle School Flood Protection HMGP #1786-113-001".

Upon motion by Mr. Errol Domingues, and duly seconded by Mr. Paul Bourgeois, and unanimously carried, the Police Jury approved Partial Payment No. 1, to Glenn Lege Construction, Inc., in the amount of \$73,806.88, relative to the "Highway 331 Realignment CIAP # F12AF70084".

Upon motion by Mr. Pervis Gaspard, and duly seconded by Mr. Ronald Menard, and unanimously carried, the Police Jury approved to enter into an Engineering Contract with Sellers & Associates, Inc., related to 2016-2017 Capital Improvements Program and authorize the President to sign the contract.

Upon motion by Mr. Errol Domingues, and duly seconded by Mr. Pervis Gaspard, and unanimously carried, the Police Jury approved to publish a public notice in the Official Journal, related to the closure of St. Hillary Road between LA Hwy 331 and St. Patrick Road.

President Darby recognized the reports of the Courthouse/Building Committee Recommendation to be presented.

Mr. Paul Bourgeois asked if there were any changes or amendments to the Courthouse/Building Committee Recommendation to be presented.

Upon motion by Mr. Paul Bourgeois, and duly seconded by Mr. Sandrus Stelly, and unanimously carried, the Police Jury approved the Courthouse/Building Committee Recommendation as presented, and the appropriate officials were authorized to carry out the recommendations.

In accordance with the Public Road Committee Recommendations, the following ordinance was adopted:

## ORDINANCE

## 2016-0-17

WHEREAS, it has been brought to the Police Jury's attention that a considerable amount of speeding exists, which is causing very hazardous conditions on Catherine Road for its entire length, in Election District No. 10.

SECTION I: NOW THEREFORE, BE IT HEREBY ORDAINED, that the Vermilion Parish Police Jury does hereby impose a 15 mph speed limit on Catherine Road, for its entire length, in Election District No.10.

SECTION II: BE IT HEREBY FURTHER ORDAINED, that the appropriate speed limit signs be installed in said area.

SECTION III: BE IT HEREBY FURTHER ORDAINED, that for a first offense, a maximum penalty of a \$100.00 fine and/or a 10 day jail sentence be imposed at the discretion of the court for the first offense.

BE IT HEREBY FURTHER ORDAINED, that for a second offense, a maximum penalty of a \$250.00 fine and/or a 10 day jail sentence be imposed at the discretion of the court.

BE IT HEREBY FURTHER ORDAINED, that for a third offense, a maximum penalty of a \$500.00 fine and/or a 10 day jail sentence be imposed at the discretion of the court.

SECTION IV: BE IT HEREBY FURTHER ORDAINED, that the Vermilion Parish Sheriff's Department be and is hereby requested and/or directed to enforce the speed limit by the use of radar and/or regular patrolling.

President Darby recognized the reports of the Finance Committee Recommendation to be presented.

Mr. Moresi stated that Ms. Duhon gave him a copy of the minutes of the Finance Committee and that there was a recommendation for the overflow of prisoners to go to a maximum of sixty (60) by August 1<sup>st</sup>, thirty (30) by September 1<sup>st</sup> and twenty (20) by October 1<sup>st</sup>. The things I would like to point out is this is going to take some coordination. Someone is going to have to find out where the overflow prisoner is, identify them and for example if there is eighty (80) they will not all be in one parish, someone will have to decide which ones you will pay and not to pay then notify those Sheriff's in advance and let them know as of this day the Jury will only pay \$4.50 per day.

Lengthy discussion followed.

Upon motion by Mr. Wayne Touchet, and duly seconded by Mr. Mark Poche', and unanimously carried, the Police Jury amended the Finance Committee Recommendations to add to Item No. 2 to authorize Mr. Paul Moresi, III, Legal Counsel to prepare a letter to send to all Correctional Facilities in Louisiana and Vermilion Parish Sheriff.
