President Darby recognized Mr. Peter Williams, Candidate for U.S. Senate to present his business to the Jury.

Upon motion by Mr. Mark Poche', duly seconded by Mr. Kevin Sagrera, and unanimously carried, the Police Jury approved payment of the attached bills that were submitted.

President Darby recognized Mr. Paul Moresi, III, Legal Counsel, to present his business to the Police Jury at this time.

Mr. Moresi, informed the Jury that Mr. Stanley Stufflebeam, in 1993 bought a lot in Oak View Subdivision. He would have qualified for homestead exemption but his tax notice was sent to his old address in Lafayette, LA on the deed and that is where the notice went to. He stated that he had never received the notice so did not apply for homestead exemption. The lot went up for tax sale and no one had bided on it so it was adjudicated to the Police Jury. Once adjudicated to the Police Jury it is off of the tax roll because the public bodies do not pay taxes. Early this year Stufflebeam was going to buy the property next door and he spoke to an attorney and while doing the title work the attorney came across the adjudication. Mr. Stufflebeam called Mr. Moresi and asked if the Parish was going to take his house. With that being said they looked into doing a quick claim deed. Mr. Stufflebeam is represented by local Attorney Bernard Duhon. Mr. Moresi suggests that back in 1993, because he did not apply for homestead exemption he would have owed \$187.39 in Parish Taxes and also would have also owed city taxes which falls outside the homestead exemption. For the last twenty three (23) years if all the taxes were added all up he would owe \$467.00. Mr. Moresi suggested if he pays his City and Parish Taxes that should be sufficient consideration for the Jury to give Mr. Stufflebeam his property back. Along with the fact if you avoid him, he would probably file a lawsuit and ask for the adjudicated property be set aside since he says he never received the notice.

Upon motion by Mr. Wayne Touchet, duly seconded by Ms. Mark Poche', and unanimously carried, the Police Jury authorized a Quitclaim Deed to Stanley Stufflebeam on property described as 0.615 Acres in Section 57 T12S R3E, Tract D Oakview Subdivision. In consideration of same, Mr. Stufflebream will pay the 1993 parish property tax of \$187.39, and will pay the city taxes from 1993 to date, totaling \$466.67.

Mr. Moresi stated previously he had discussed about the lawsuit Shelana Carter vs. Vermilion Parish Police Jury. This was the inmate in the jail that stated she was not given proper medical care. The Police Jury approved to hire a special counsel Mr. Joel Babineaux. Mr. Moresi stated he had told the Jury the rate was \$200.00/ hour but it is really \$225.00/ hour. Mr. Moresi would like to amend the agenda.

Upon motion by Mr. Cloris Boudreaux, duly seconded by Mr. Kevin Sagrera, and unanimously carried, the Police Jury amended the agenda to allow Mr. Paul Moresi, III, Legal Counsel, to present his business to the Police Jury at this time, relative to lawsuit Shelana Carter vs. Vermilion Parish Police Jury. Upon motion by Mr. Mark Poche', duly seconded by Ms. Wayne Touchet, and unanimously carried, the Police Jury adopted a Resolution to hire Mr. Joel P. Babineaux, Attorney with Babineaux, Poche, Anthony firm to act as special counsel to defend the Vermilion Parish Police Jury and Mr. Ronald Menard in the matter of Shelena Carter vs. et al Vermilion Parish Police Jury, at a rate of \$225.00 per hour and authorize the President to sign all necessary documents.
