ORDINANCE 2019-O-03

AN ORDINANCE AUTHORIZING THE PUBLIC SALE OF SURPLUS PROPERTY OWNED BY THE VERMILION PARISH POLICE JURY.

WHEREAS, the VERMILION PARISH POLICE JURY, a political subdivision of the State of Louisiana, and the governing authority of the Parish of Vermilion, is the lawful owner of the immovable property and improvements described as:

That certain tract of land, along with all buildings and improvements located thereon, designated as TRACT "A" lying and being situated in the SOUTHWEST PORTION OF FRACTIONAL SECTION TWENTY-FIVE (25) and the EASTERN PORTION OF FRACTIONAL SECTION TWENTY-SIX (26), TOWNSHIP TWELVE (12) SOUTH, RANGE THREE (3) EAST of the THIRD WARD OF VERMILION PARISH, STATE OF LOUISIANA, containing 2.296 acres, and being more fully shown on a plat of survey prepared by J. E. Schexnaider & Associates, Inc., dated March 2, 1998, recorded in the office of the Clerk and Recorder for the Parish of Vermilion, State of Louisiana, under Entry Number: 98-04622.

Said tract being bounded on the North of Vernon Avenue, West by Schlessinger Street South by Martin Luther King Drive and East by Tract "B" said plat of survey.

Referred to hereinafter as the "Subject Property"

WEHREAS, the VERMILION PARISH POLICE JURY has determined that the Subject Property is no longer needed for public purposes and has determined that it is surplus property; and

WHEREAS, improvements on the Subject Property are nearing the end of their functional lifespan and are in need of repair; and

WHEREAS, the VERMILION PARISH POLICE JURY has determined that it is in the public interest to sell the Subject Property by public sale; and

WHEREAS, the fair market value of the Subject Property, as appraised and determined by Broussard Appraisal Service, is TWENTY THOUSAND AND NO/100 (\$20,000.00) DOLLARS; and

WHEREAS, VERMILION PARISH POLICE JURY wishing to avail itself of the authority granted to it pursuant to LSA-R.S. 33:4711 and following, proposes this Ordinance in order to authorize a public sale of the Subject Property to the highest bidder for the minimum bid of TWENTY THOUSAND AND NO/100 (\$20,000.00) DOLLARS; and

THEREFORE, BE IT ORDAINED by the Police Jury of Vermilion Parish, in regular session convened on this <u>4th</u> day of <u>March</u>, 2019, that the Vermilion Parish Police Jury adopt Parish Ordinance No. 2019-O-03 as follows:

Sec. 1. <u>Purpose</u>. The purpose of this Ordinance is to authorize the public sale of surplus property described herein (the Subject Property), from the Vermilion Parish Police Jury to the highest bidder, under the authority of LSA-R.S. 33:4711 and following.

Sec. 2. <u>Terms of Sale.</u> The Subject Property and improvements shall be sold in their current condition, "AS IS", without any warranty as to condition, nor warranty as to the Subject Property being fit for any intended purpose. The minimum bid shall be Twenty Thousand and no/100 (\$20,000.00) Dollars, cash, payable at closing by the highest bidder.

Sec. 3. <u>**Opposition, Public Hearing.**</u> Opposition to this Ordinance must be in writing and filed with the Administrator of VERMILION PARISH POLICE JURY at 100 North State Street, Suite 200, Abbeville, Louisiana, within fifteen (15) days after first publication of notice of this proposed ordinance. If written opposition is timely filed, a public hearing shall be held for the purpose of hearing any opposition to said Ordinance and the public sale of the Subject Property.

Sec. 5. Repeal of conflicting ordinances.

All ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.

Sec. 6. Severability.

Should any part of this ordinance be declared null, void, invalid, illegal or unconstitutional, the remainder of the said ordinance shall remain in full force and effect.

Sec. 7. Effective date.

This ordinance shall become effective after final approval of the Vermilion parish Police Jury, signature of the President of the Vermilion Parish Police Jury, promulgation and legal delay.
