Minutes of a regular meeting of the Vermilion Parish Police Jury held on April 01, 2019, with President Kevin Sagrera presiding.

The meeting was called to order by President Kevin Sagrera, who asked Mr. Leon Broussard to lead the group in the Pledge of Allegiance. Following the pledge, the President asked Mr. Ronald Darby for a moment of prayer or reflection. The President then reminded all present to turn all cell phones, pagers, etc. off or set to silent mode for the duration of the Police Jury Meeting.

President Sagrera recognized a period for public comment on any agenda item to be considered.

Mr. Paul Moresi, III, Legal Counsel, presented the following timeline in regards to the Old Herod Building:

- In 1998, the School Board made a donation of the Old Herod School Building to three (3) different organizations
 - The Police Jury
 - Herod Village, Inc.
 - The City of Abbeville
- The donation had requirements for each of those organizations to do certain things
 - The City of Abbeville was required to make a public park out of its share of the property
 - Herod Village, Inc. had to use it for educational service and other benefits to the community
 - The Police Jury agreed to use the property to operate an educational facility
- It also says in the event the properties are ceased to be used for the purposes described in the donation the property would revert back to the School Board and would require the School Board to notify the three (3) organizations, who received the property, in writing at least thirty (30) days in advance if they intended to take the property back.
- In 2010, there was an Intergovernmental Agreement and Lease between the Police Jury and Herod Village, Inc. (non-profit) in which Herod Village was able to utilize the property to pay a dollar a month rent but was required to be responsible for the maintenance, repairs, insurance and any taxes associated with those activities. It was also required to purchase \$500,000.00 in liability insurance and required to be used for charitable, religious, scientific literary and educational purposes. The lease did not have a specific term. It was for an indefinite term, which means, either party could terminate such a lease by giving thirty (30) days' notice. It also has an option to purchase at fair market value.
- In 2014, there was an Intergovernmental Agreement between the Police Jury, Herold Village, Inc. and Vision of Hope where the lease was assigned from Herod Village, Inc. to Vision of Hope. So Vision of Hope now has the rights Herod Village, Inc. had.
- Everything was in the agenda and discussed at open meetings
- In 2018, it was reported to the Police Jury that Pastor Stevens was housing homeless men. Explained the steps taken in this incident.
- In February 2019 received the check of \$3,500.00 for the appraisal of the Old Herod Building (the portion the VPPJ has)
- Once the appraisal was completed I presented the Jury the appraisal amount and then explained the process of the private notice/private sale and then the public notice/public bid process.
- The agreement made with Pastor Stevens was if he bought the property he would get credit against the \$3,500.00 he has already paid and if he didn't buy it and someone else bought the property then he would receive a reimbursement of the \$3,500.00 paid for the appraisal.
- If you do decide to sale the property without restrictions the Jury needs to write to the School Board and get approval
