ORDINANCE 2022-O-05

AN ORDINANCE REGULATING THE CONSTRUCTION OF PONDS IN THE UNINCORPORATED AREAS OF VERMILION PARISH, LOUISIANA

BE IT ORDAINED by the Vermilion Parish Police Jury that there is a need to protect the public safety, health and welfare of the citizens of the Parish of Vermilion in reference to the construction of ponds in the unincorporated areas of Vermilion Parish, Louisiana;

BE IT FURTHER ORDAINED by the Police Jury of Vermilion Parish, in regular session convened on this 15TH day of June, 2022, that the Vermilion Parish Police Jury adopt Parish Ordinance No. 2022-O-05 as follows:

Sec. 1. DEFINITIONS:

"POND" as used herein means:

A man-made body of water located on the lands of a single owner, or of a single group of joint owners, which does not have an outlet, or has a small outlet, to any public bodies of water.

Sec. 2. PERMIT REQUIRED:

Any person (including but not limited to a landowner, lessee, possessor, permittee, invitee, business entity or governmental body) wishing to create, expand, improve or repair a POND on property located in Vermilion Parish, Louisiana shall first obtain a permit from the Vermilion Parish Police Jury.

PONDS in existence on the effective date of this Ordinance are exempted from the requirement of obtaining a permit. However, if said PONDS are enlarged, expanded, improved or repaired subsequent to the effective date of this Ordinance, any such enlargement, expansion, improvement or repair of a POND shall require a permit and shall be in compliance with the requirements of this Ordinance.

Additionally, PONDS in existence on the effective date of this Ordinance may not encroach on property not owned by the owner or possessor of said POND.

Sec 3. FORM OF PERMIT:

The permit application shall be on forms approved by the Vermilion Parish Police Jury.

Sec 4. <u>REQUIREMENTS:</u>

All requirements set forth in the permit application shall be submitted, including a plat of survey showing the amount of acreage of the land, location of the POND on said land, depth of the POND, width of the POND, slope of the POND, the location and size of overflow, and the location of the placement of the spoil and/or excavated soil. The location and construction of a POND shall comply with all setback restrictions approved by the Parish engineer and set forth in the permit.

Sec 5. EXEMPTIONS:

PONDS created by persons engaged in the business of agriculture shall be exempt from the requirement of a permit.

Sec. 6. CRIMINAL LIABILITY:

Any person who violates this Ordinance shall, upon conviction thereof, be guilty of a misdemeanor and shall be subject to a fine of not more than Five Hundred and no/100 (\$500.00) Dollars, or a prison term of not more than thirty (30) days, or both, for each violation. Each day that a violation of this ordinance exists shall be considered a separate offense.

Sec. 7. REPEAL OF CONFLICTING ORDINANCES:

All ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.

Sec. 8. SEVERABILITY:

Should any part of this ordinance be declared null, void, invalid, illegal or unconstitutional, the remainder of the said ordinance shall remain in full force and effect.

Sec. 9. EFFECTIVE DATE:

This ordinance shall become effective after final approval of the Vermilion Parish Police Jury, signature of the President of the Vermilion Parish Police Jury, promulgation and legal delay.

RESOLUTION 2022-R-07

A resolution authorizing the establishment of one or more deposit accounts at First Guaranty Bank on behalf of the Vermilion Parish Police Jury for the deposit of public funds; providing for the President to designate authorized persons to act on such accounts; and providing for other matters in connection therewith.

WHEREAS, the Vermilion Parish Police Jury, acting through its governing authority, the Vermilion Parish Police Jury, pursuant to law, desires to provide for the deposit and disbursement of public funds held by the Vermilion Parish Police Jury in order to carry out its public functions; and

WHEREAS, the Vermilion Parish Police Jury desires to establish one or more deposit accounts with First Guaranty Bank for this purpose.

NOW, THEREFORE, BE IT RESOLVED by the Vermilion Parish Police Jury, acting as the governing authority of the Parish that:

SECTION 1. One or more deposit accounts shall be established by the Vermilion Parish Police Jury with First Guaranty Bank for the deposit and disbursement of public funds to enable the Vermilion Parish Police Jury to carry out its public functions.

SECTION 2. The President be and he is hereby authorized, empowered and directed to represent the Vermilion Parish Police Jury in connection with said deposit accounts, which shall be on such terms and conditions as said President, in his sole discretion, deems fit and proper.

SECTION 3. The President is authorized to manage and operate said accounts, including but not limited to designate authorized signers on the accounts to make deposits, sign and endorse checks and negotiable instruments on behalf of the Vermilion Parish Police Jury and withdraw or transfer funds from said accounts as he deems advisable; and to execute all documents in connection therewith and as he may deem necessary to effect the transactions contemplated by this Resolution. Those authorized signers being Jason Picard – President, Brent Landry – Vice President, Keith Roy – Administrator, Carolyn Bessard – Assistant Administrator, and Timothy J. Baudoin – Treasurer.

SECTION 4. This Resolution shall become effective immediately. All prior acts undertaken on behalf of the Vermilion Parish Police Jury with respect to deposit accounts with First Guaranty Bank are ratified and confirmed.
