ORDINANCE
2001-O-17

AN ORDINANCE AMENDING ORDINANCE 2001-O-17 REGULATING
TRAFFIC ON PARISH ROADS WITHIN RECOGNIZED SUBDIVISIONS OF
THE PARISH OF VERMILION, WHICH WAS ADOPTED ON SEPTEMBER 17,
2001.

BE IT ORDAINED by the Police Jury of Vermilion Parish, in regular session convened on this 21st day of September, 2022, that the Vermilion Parish Police Jury hereby amends the Parish Ordinance No. 2001-O-17 relative to establishing guidelines for parking, and for the maximum load limits, pertaining to vehicles operating on parish roads in the Parish of Vermilion.

BE IT FURTHER ORDAINED that it is the desire of the Vermilion Parish Police Jury to amend Ordinance No. 2001-O-17 to have same read as follows:

SECTION 2.

A. Except as otherwise provided herein, all vehicles are prohibited from parking on parish roads and parish road rights-of-way, including but not limited to parish roads and parish road rights-of way located within recognized subdivision of the Parish of Vermilion, Louisiana.

B. Municipal and Parish utility and service vehicles, farm vehicles while engaged in agricultural activities and properly flagged, church services, funeral services, fairs and festivals, and vehicles engaged in brief loading and unloading are exempt from Section 2A of this Ordinance, provided, however, that any vehicle entitled to this exemption shall be parked in such a manner as to not impede the safe flow of traffic.

BE IT FURTHER ORDAINED that all other provisions of Ordinance No. 2001-O-17 shall remain the same.
