**ORDINANCE NUMBER  
2022-O-04**

**AN ORDINANCE REDISTRICTING  
THE ELECTION DISTRICTS OF THE  
VERMILION PARISH POLICE JURY**

**WHEREAS**, the Vermilion Parish Police Jury is mandated by Louisiana State Law, specifically Louisiana Revised Statute §33:1411, to examine the Parish's existing apportionment plan to determine if said apportionment plan is equitable;

**WHEREAS**, the Vermilion Parish Police Jury, after evaluating the proposed apportionment plan which was presented on April 20, 2022, has found said plan to be equitable;

**WHEREAS**, the Vermilion Parish Police Jury desires to reapportion itself in accordance with the authority granted by the Louisiana Election Code.

**NOW, THEREFORE, BE IT ORDAINED** by the Vermilion Parish Police Jury as follows:

**SECTION 1.** For the purpose of electing members to the Vermilion Parish Police Jury, as well as other police jury election purposes, the Parish of Vermilion's fourteen (14) Police Jury Election Districts are redistricted as defined per attached maps marked Exhibit "A" to this ordinance.

**SECTION 2.** This ordinance shall become effective on May 18, 2022.

**SECTION 3.** This ordinance, along with all of the required digital format mapping, shall be submitted by the President of the Police Jury to the U.S. Census Bureau and the Louisiana Secretary of State.

**SECTION 4.** Should any section or provision of this ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the ordinance as a whole or any part thereof, other than the part so declared unconstitutional or invalid.

**SECTION 5.** All ordinances or part of ordinances in conflict herewith or incompatible with the provisions of this ordinance are hereby repealed.




