AS A RESULT OF A COURTHOUSE/GENERAL NEEDS COMMITTEE MEETING HELD ON NOVEMBER 02, 2023, THE FOLLOWING ITEMS ARE RESPECTFULLY SUBMITTED FOR THE JURY'S CONSIDERATION:

1. It is recommended the Police Jury approve to accept the renewal for life (increase .04%) and health rates for the group health (increase 5%) insurance and allow the Administrator to execute the document. Along with Mr. Campisi provide the cost of increasing employee life insurance coverage to \$10,000.


