President Poche' recognized the discussion and review of the 2025 Budget by Mr. Tim Baudoin, Treasurer.

Mr. Tim Baudoin, Treasurer, presented the following:


➤ 2025 Proposed Budget – Combined Statement

Upon motion by Mr. Ronald Darby, duly seconded by Mr. Dane Hebert, and unanimously carried, the Police Jury approved to increase the Fire Department allocations for each fire department (raise the \$10,000 base to \$14,000 for departments with low population and increase the allocation for departments whose budget are based on population numbers to \$6.00 per resident in their coverage area).


- Re-allocate the funds from the Vermilion Economic Development Alliance to use towards the Part-time employee for the Coastal Restoration Group (\$35,000) paid out of 78.
- \$60,000 to go towards renovations at the Old Health Unit building
- 3% cost of living increase for VPPJ employees
- 3% cost of living increase for the two Judges Secretaries located in Vermilion Parish
- 3% cost of living increase for the Administrative Staff for the Abbeville City Court (this increase only includes the Parish's share)

Upon motion by Mr. Brent Landry, duly seconded by Mr. Shane Meaux, and unanimously carried, the Police Jury approved to accept and adopt the 2025 Budget as amended.

Upon motion by Mr. Chad Vallo, duly seconded by Mr. Ronald Menard, and unanimously carried, there being no further business to be presented, the meeting was duly adjourned.
