SECTION 1. <u>Canvass</u>. SUB-ROAD DISTRICT NO. 1 OF ROAD DISTRICT NO. 2 OF THE PARISH OF VERMILION, STATE OF LOUISIANA PROPOSITION (TAX RENEWAL)

Shall Sub-Road District No. 1 of Road District No. 2 of the Parish of Vermilion, State of Louisiana (the "District"), continue to levy a special tax of 5.06 mills on all property subject to taxation in the District (an estimated \$416,700 expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of maintaining the roads in the District?

This Governing Authority does further proceed to examine and canvass the returns of the Elections thereof.

SECTION 2. <u>Election Results.</u> According to the official certified tabulation of votes cast at said Elections,

- i. there was a total of **14,056** votes cast **IN FAVOR OF** the Parishwide Proposition and a total of **10,707** votes cast **AGAINST** the Parishwide Proposition, resulting in a majority of **3,349** votes cast **IN FAVOR OF** the Parishwide Proposition; and
- ii. there was a total of **3,287** votes cast **IN FAVOR OF** the Sub-Road District No. 1 of Road District No. 2 Proposition and a total of **2,885** votes cast **AGAINST** the Sub-Road District No. 1 of Road District No. 2 Proposition, resulting in a majority of **402** votes cast **IN FAVOR OF** the Sub-Road District No. 1 of Road District No. 2 Proposition.

The Propositions were therefore duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the Elections.
