- ♦ Who is doing this?

- ♦ Why are we doing this?

 To provide information on the proper operation and maintenance of your home sewage treatment system, the importance of routine inspections and how to identify repairs needed on your individual system.
- ♦ What happens in an inspection?

 A visual inspection of the system will take place and recommendations regarding proper sewer system operating practices will be offered.
- What is the cost of an inspection?

 The inspection is absolutely FREE!
- ♦ How can I schedule my **FREE** inspection?

- ♦ How long will the inspection take?

 The average inspection will take approximately 15-20 minutes.
- ♦ Will I get penalized for having a non-functional system?

 No penalties will be imposed. We are here to help! But we will recommend a corrective plan of action for your particular system.

Suggested Operating Tips

- ♦ Have routine inspections conducted (annually)
- Pump out system at 4 to 5 year intervals
- ♦ Make sure aerator is plugged in and operating
- ♦ Clean/change filters on aerators at regular intervals
- Do not flush/discard garbage into sewer system (baby wipes, diapers, cigarette butts, feminine products, condoms, cotton swabs, band aids, etc)
- Do not dispose of harsh chemicals, old medications, grease and other harmful liquids into your sewer system
- Ensure all access lids and caps fit properly so as not to allow rain water to enter sewer system
- ♦ Check discharge periodically to prevent obstructions
- If repairs are needed, make sure they are done by a professional
