RESOLUTION 2023-R-10

A resolution ordering and calling a special election to be held in the Vermilion Economic Development District in the Parish of Vermilion, State of Louisiana, on Saturday, March 23, 2024, to authorize a special tax therein for the Vermilion Economic Development District.

WHEREAS, the Board of Commissioners of Vermilion Economic Development District of the Parish of Vermilion, State of Louisiana (the "Governing Authority"), acting as the governing authority of Vermilion Economic Development District of the Parish of Vermilion, State of Louisiana (the "District"), adopted a resolution on July 21, 2023, calling a special election in the district on Saturday, March 23, 2024, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Police Jury, acting as the governing authority of the Parish of Vermilion, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Police Jury to approve the holding of said election and in the event that the election carries, to continue to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Vermilion. State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1, In compliance with the provision of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Vermilion Economic Development District of the Parish of Vermilion, State of Louisiana, this Police Jury hereby approves the holding of an election in the District, on Saturday, March 23, 2024 at which election there will be submitted the following proposition, to-wit:

PROPOSITION

Shall the Vermilion Parish Economic Development District, State of Louisiana (the "District"), be authorized to levy an annual parcel fee of \$6.50 on all the property subject to taxation in Vermilion Parish, for a period of ten (10) years, beginning with the year 2024 and ending with

the year 2033 (an estimated \$243,750.00 reasonably expected at this time to be collected from the levy of the fee for an entire year), for the purpose of conducting activities that stimulate the economy, leverage local resources, and/or provide workforce opportunities?

SECTION 2. In the event the election Carries, this Police Jury does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.
