- 3. To establish the process for selecting a new parish administrator, whereby VPPJ members will vote on all applicants after the interviews. If any applicant gets a majority of the members present, and voting, that person will be appointed parish administrator. If no applicant gets such a majority, then the 3 applicants who receive the most votes will enter a second round of voting. If any of the remaining 3 applicants receives a majority of votes of the members present, and voting, that person is appointed parish administrator. If not, the 2 applicants received a majority of the members present and voting, and the applicant who received a majority of the members present and voting will be selected as parish administrator.

Upon motion by Mr. Chad Vallo, duly seconded by Mr. Dexter Callahan, and unanimously carried, there being no further business to be presented, the meeting was duly adjourned.
