A resolution authorizing the establishment of one or more deposit accounts at First Guaranty Bank on behalf of the Vermilion Parish Police Jury for the deposit of public funds; providing for the President to designate authorized persons to act on such accounts; and providing for other matters in connection therewith.

WHEREAS, the Vermilion Parish Police Jury desires to establish one or more deposit accounts with First Guaranty Bank for this purpose.

NOW, THEREFORE, BE IT RESOLVED by the Vermilion Parish Police Jury, acting as the governing authority of the Parish that:

SECTION 1. One or more deposit accounts shall be established by the Vermilion Parish Police Jury with First Guaranty Bank for the deposit and disbursement of public funds to enable the Vermilion Parish Police Jury to carry out its public functions.

SECTION 2. The President be and he is hereby authorized, empowered and directed to represent the Vermilion Parish Police Jury in connection with said deposit accounts, which shall be on such terms and conditions as said President, in his sole discretion, deems fit and proper.

SECTION 3. The President is authorized to manage and operate said accounts, including but not limited to designate authorized signers on the accounts to make deposits, sign and endorse checks and negotiable instruments on behalf of the Vermilion Parish Police Jury and withdraw or transfer funds from said accounts as he deems advisable; and to execute all documents in connection therewith and as he may deem necessary to effect the transactions contemplated by this Resolution. Those authorized signers being Mark Poche' – President, Chad Vallo – Vice President, Keith Roy – Administrator, Carolyn Bessard – Assistant Administrator, and Timothy J. Baudoin – Treasurer.

SECTION 4. This Resolution shall become effective immediately. All prior acts undertaken on behalf of the Vermilion Parish Police Jury with respect to deposit accounts with First Guaranty Bank are ratified and confirmed.

BE IT RESOLVED by the Police Jury of the Parish of Vermilion, State of Louisiana (the "Governing Authority"), acting as the governing authority of (i) the Parish of Vermilion, State of Louisiana, (ii) Road District No. 1 of the Parish of Vermilion, State of Louisiana, (iii) Road District No. 4-A of the Parish of Vermilion, State of Louisiana, (iv) Road District No. 6 of the Parish of Vermilion, State of Louisiana and (v) Sub-Road District No. 1 of Road District No. 2 of the Parish of Vermilion, State of Louisiana (the "Parish and Districts"), that:

SECTION 1. <u>Canvass</u>. This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special elections held in the Parish and Districts on SATURDAY, APRIL 27, 2024 (the "Elections"), to authorize the renewal of ad valorem taxes therein pursuant to the following propositions (the "Propositions"):

PARISH OF VERMILION. STATE OF LOUISIANA PROPOSITION (TAX RENEWAL)

Shall the Parish of Vermilion, State of Louisiana (the "Parish"), continue to levy a special tax of 3.26 mills on all property subject to taxation in the Parish (an estimated \$1,106,600 expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of maintaining and keeping in repair the public roads and highways of the Parish?

ROAD DISTRICT NO. 1 OF THE PARISH OF VERMILION, STATE OF LOUISIANA PROPOSITION (TAX RENEWAL)

Shall Road District No. 1 of the Parish of Vermilion, State of Louisiana (the "District"), continue to levy a special tax of 5.72 mills on all property subject to taxation in the District (an estimated\$150,400 expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of maintaining the roads in the District?

ROAD DISTRICT NO. 4-A OF THE PARISH OF VERMILION, STATE OF LOUISIANA PROPOSITION (TAX RENEWAL)

Shall Road District No. 4-A of the Parish of Vermilion, State of Louisiana (the "District"), continue to levy a special tax of 6.93 mills on all property subject to taxation in the District (an estimated \$157,200 expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of maintaining the roads in the District?

ROAD DISTRICT NO. 6 OF THE PARISH OF VERMILION, STATE OF LOUISIANA PROPOSITION (TAX RENEWAL)

Shall Road District No. 6 of the Parish of Vermilion, State of Louisiana (the "District"), continue to levy a special tax of 6.27 mills on all property subject to taxation in the District (an estimated

\$108,000 expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of maintaining the roads in the District?

SUB-ROAD DISTRICT NO. 1 OF ROAD DISTRICT NO. 2 OF THE PARISH OF VERMILION, STATE OF LOUISIANA PROPOSITION (TAX RENEWAL)

Shall Sub-Road District No. 1 of Road District No. 2 of the Parish of Vermilion, State of Louisiana (the "District"), continue to levy a special

tax of 5.06 mills on all property subject to taxation in the District (an estimated \$416,700 expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of maintaining the roads in the District?

This Governing Authority does further proceed to examine and canvass the returns of the Elections thereof.

SECTION 2. <u>Election Results.</u> According to the official certified tabulation of votes cast at said Elections,

- (i) there was a total of **1,003** votes cast **IN FAVOR OF** Parishwide Proposition and a total of **1,106** votes cast **AGAINST** Parishwide Proposition, resulting in a majority of **103** votes cast **AGAINST** Parishwide Proposition;
- (ii) there was a total of **60** votes cast **IN FAVOR OF** Road District No. 1 Proposition and a total of **54** votes cast **AGAINST** Road District No. 1 Proposition, resulting in a majority of **6** votes cast **IN FAVOR OF** Road District No. 1 Proposition;
- (iii) there was a total of **39** votes cast **IN FAVOR OF** Road District No. 4-A Proposition and a total of **31** votes cast **AGAINST** Road District No. 4-A Proposition, resulting in a majority of **8** votes cast **IN FAVOR OF** Road District No. 4-A Proposition;
- (iv) there was a total of 69 votes cast **IN FAVOR OF** Road District No. 6 Proposition and a total of 43 votes cast **AGAINST** Road District No. 6 Proposition, resulting in a majority of 26 votes cast **IN FAVOR OF** Road District No. 6 Proposition; and
- (v) there was a total of **290** votes cast **IN FAVOR OF** Sub-Road District No. 1 of Road District No. 2 Proposition and a total of **404** votes cast **AGAINST** Sub-Road District No. 1 of Road District No. 2 Proposition, resulting in a majority of **114** votes cast **AGAINST** Sub-Road District No. 1 of Road District No. 2 Proposition.

The Parishwide Proposition and Sub-Road District No. 1 of Road District No. 2

Proposition were therefore duly **DEFEATED** and Road District No. 1Proposition, Road District No. 4-A Proposition and Road District No. 6 Proposition were therefore duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the Elections.

SECTION 3. <u>Promulgation of Election Result.</u> The results of said elections shall be promulgated by publication in the manner provided by law, after receipt from the Secretary of State's office of the actual costs of the elections, as required by §18:1292 of the Louisiana Revised Statutes of 1950, as amended.

SECTION 4. <u>Declaration</u>. The foregoing results of the Elections are hereby declared by this Governing Authority and shall be published as required by law.

SECTION 5. <u>Procès Verbal.</u> A *Procès Verbal* of the canvass of the returns of the Elections shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in her office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of Vermilion, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.
